RHIM STRATEGIC MODEL FACTSHEET


The RHIM Strategic model is a defensive multi-asset portfolio which aims to generate growth ahead of inflation over a rolling 3 year period yet operate with a low level of volatility, using collective investment schemes (funds). The emphasis is on capital preservation and steady returns. The majority of the model will be invested in lower risk funds, with a maximum of 30% permitted in traditional equity funds. Targeted absolute return funds and fixed income will be used, in addition to property and cash as deemed appropriate. Asset allocation will be actively managed whilst maintaining a low risk profile. Any falls in the value of a portfolio should usually be small. However, potential returns are also likely to be modest. The model will sit within risk profile 3 on a scale of 1-10, where 1 is cash and 10 is 100% in emerging markets. Please see the reverse for historical volatility and peak to trough data.




Commentary

SEPTEMBER 2018 UPDATE

The model fell slightly over the month, down by 0.32%, as most non-US equity markets fell and bond yields rose. Equities are falling in part because yields are rising and we have been wary of this scenario for some time. Hence the model remains diversified through other sectors and asset classes, not just bonds, such as targeted absolute return funds and more recently some gold exposure. The best performing fund in September was RWC Enhanced Income which rose 1.2% whilst the weakest was Newton International Bond which fell 1.4%. The latter is held in case of a sterling depreciation should we fail to reach a satisfactory exit from the EU. Over the year the model benefited most from its exposure to Polar Capital Global Convertibles which rose 12.7% and M&G Global Dividend which gained 14.7%. We de-risked some of our equity holdings earlier in the year, taking profits on Unicorn UK Income in favour of the more defensive RWC Enhanced Income fund. The more defensive elements of the model held back returns overall, whilst gold acted as a detractor over the six months.
