RHIM INCOME MODEL FACTSHEET

The RHIM Income model aims to produce a yield in the region of the FTSE All Share and modestly grow the capital over the medium term. The model is likely to experience similar volatility to the IA sector given that it stays fully invested within income producing assets throughout the cycle. This is a multi-asset global income portfolio with an equity weight between 40% and 55% which will include overseas equity exposure, balanced with at least 35% in fixed interest and property as deemed appropriate. Asset allocation will be actively managed whilst maintaining a balanced risk profile. Income generated can be withdrawn or reinvested. Investors should be comfortable with periods of volatility, although this is expected to be less than a pure equity portfolio. Withdrawing income will reduce growth potential. The model will sit in profile 5 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.

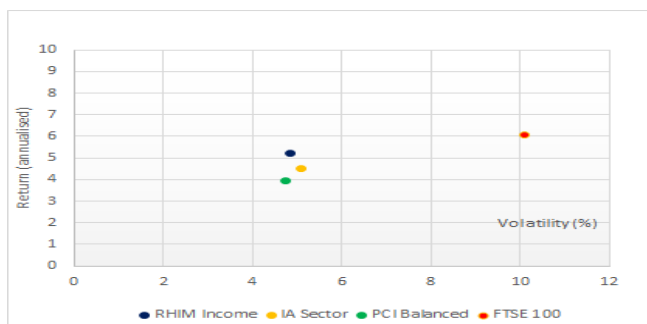


Commentary

MARCH 2019 UPDATE

The model gained 5.8% over the three months as equity markets rallied sharply following the December correction. The return over twelve months was 4.1%, well above the peer group. Several funds helped contribute to this performance, including Newton Global Income (+14.3%) and M&G Global Convertibles (+11.3%). UK and European equities delivered lower returns than the global funds, the latter of which tend to have around 50% US exposure. However, the divergence between US equities and 'the rest' is unlikely to continue at this pace. Whilst we have maintained a fairly constant equity weight over the past twelve months we have made adjustments over the period to reflect a slightly more cautious stance. For example, we reduced Artemis Global Income in favour of Newton Global Income in December 2018 and increased Strategic bond exposure in January. Both of these changes have proved favourable to the performance of the model. Whilst the Income model tends to be fully invested in 'income generating' assets we have also invested a small (1.5% exposure) in the Merian Gold and Silver fund for its diversification benefits. This fund has been resilient through both the recent equity market corrections, gaining 5.2% over 3 months and 10.9% over six months. The gold price has responded well to the back-peddling by central banks and therefore falling real yields.

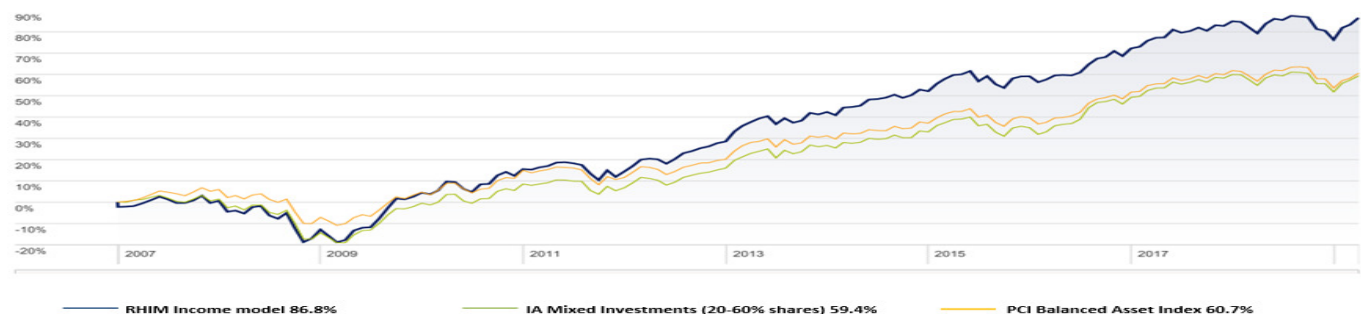
Risk Return (5 years) as at 31st March

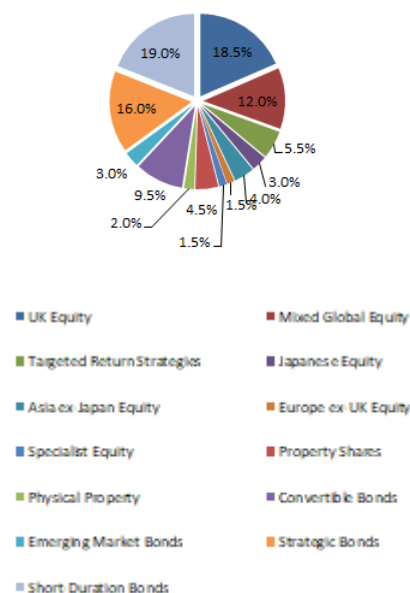
