


RHIM STRATEGIC MODEL FACTSHEET


The RHIM Strategic model is a defensive multi-asset portfolio which aims to generate growth ahead of inflation over a rolling 3 year period yet operate with a low level of volatility, using collective investment schemes (funds). The emphasis is on capital preservation and steady returns. The majority of the model will be invested in lower risk funds, with a maximum of 30% permitted in traditional equity funds. Targeted absolute return funds and fixed income will be used, in addition to property and cash as deemed appropriate. Asset allocation will be actively managed whilst maintaining a low risk profile. Any falls in the value of a portfolio should usually be small. However, potential returns are also likely to be modest. The model will sit within risk profile 3 on a scale of 1-10, where 1 is cash and 10 is 100% in emerging markets. Please see the reverse for historical volatility and peak to trough data.



Commentary APRIL 2019 UPDATE

The model gained 1.1% over the three months as equities rallied strongly when the U.S. Federal Reserve lowered its expectations for higher interest rates and the U.S. Treasury reported good progress in the talks with China. Company earnings were weaker for the first quarter and global growth decelerated sharply but share buybacks have continued to push share prices higher in the USA. Over the year, the model gained 0.2%, aided by strong returns from Newton Global Income (+15.8%) and Polar Capital Global Convertibles (+8.7%). The fixed income funds generated good returns in a difficult period for non-US equities with the Janus Henderson Strategic Bond fund up 4% and the Jupiter Strategic Bond fund up 3.7%. The model's equity long/short funds struggled over the year as they are positioned for US equities to fall. The two funds were down 6.6% and 10.8% over the year. However, the funds performed well in October and December 2018 protecting client capital in the sell-off. The Merian Gold & Silver fund was the worst performing fund down 12.6% over the year but it also performed strongly when markets fell in 2018. The fund will be volatile, but we think it will be a key beneficiary of the US-China trade war.


