

# RHIM CAUTIOUS MODEL FACTSHEET

The RHIM Cautious model aims to deliver capital growth over the medium term, with lower volatility than the sector average using collective investment schemes (funds). Asset allocation will be actively managed whilst maintaining a cautious risk profile. This is a multi-asset portfolio which may invest between 25% and 45% in traditional equity funds which will include UK and overseas equities. The remainder will be invested in lower risk funds such as targeted absolute return funds and at least 35% across fixed income and property. The model is also permitted to hold up to 10% in cash when deemed appropriate. In order to deliver returns in excess of cash over the longer term investors must accept that the investment could fall in value, particularly in the short term. The model will sit within risk profile 4 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.




## Commentary October 2019 UPDATE

The Cautious model was down 0.4% over the last three months as equity and fixed income markets slipped. Bond yields have been rising and bond prices falling as central banks have started to push money back into the market. This has caused the gold price to fall even though central banks are printing more and more money. The global economy remains weak and company earnings have started to soften. Equity markets were down over the period but a lot of this was due to the pound strengthening when there were signs of a Brexit deal between the UK and European Union. Companies with overseas earnings became less valuable in sterling terms. It was good for more domestically-focused companies and the Franklin UK Managers' Focus fund, which has a large exposure to these companies, was up 2.1% in the three months while the FTSE 100 index of large companies was down 3.1%. The model's strategic bond funds were up 1.5% over the three months even though bond prices weakened while the Foresight UK Infrastructure Income fund, which we bought to replace some of the fixed income exposure was up 2.4%. Over the year, the Cautious model was up 4.0% on the back of higher equity and bond markets.


### Risk Return (5 years) as at 30th September 2019


