


RHIM STRATEGIC MODEL FACTSHEET

The RHIM Strategic model is a defensive multi-asset portfolio which aims to generate growth ahead of inflation over a rolling 3 year period yet operate with a low level of volatility, using collective investment schemes (funds). The emphasis is on capital preservation and steady returns. The majority of the model will be invested in lower risk funds, with a maximum of 30% permitted in traditional equity funds. Targeted absolute return funds and fixed income will be used, in addition to property and cash as deemed appropriate. Asset allocation will be actively managed whilst maintaining a low risk profile. Any falls in the value of a portfolio should usually be small. However, potential returns are also likely to be modest. The model will sit within risk profile 3 on a scale of 1-10, where 1 is cash and 10 is 100% in emerging markets. Please see the reverse for historical volatility and peak to trough data.



Commentary November 2019 UPDATE

The Strategic model was up 0.24% over the three months to November on the back of rising UK equity markets. The pound strengthened over the period which made overseas investments less valuable in sterling. Fixed income yields rose which caused the prices of bonds and gold to decline. Global growth weakened over the period but the easier financial conditions caused by central bank stimulus has pushed stockmarkets higher even though company earnings have fallen. With the likelihood of a Corbyn victory and a no-deal Brexit fading, smaller UK domestic companies outperformed the large multinationals. The FTSE 250 was up 8.1% over the three months while the FTSE 100 was up 2.9%. The fixed income funds were down 1% over the quarter but the property fund was up over 5%. The Strategic model was up 4.7% over the year to 30 November 2019, 3.2% ahead of UK CPI.
