RHIM DYNAMIC MODEL FACTSHEET

The RHIM Dynamic model aims to produce an attractive level of capital growth over the medium term with lower volatility than the IA sector, investing in collective investment schemes. This is a multi-asset global portfolio with an equity weight of between 50% and 75% which will involve investing in UK and overseas equities, including emerging markets. However, the model will typically also use targeted absolute return funds in order to reduce volatility associated with equity investing and at least 15% will be also invested in fixed interest and/or property as deemed appropriate. Asset allocation will be actively managed around the higher side of medium risk profile. This means investors should be comfortable with periods of volatility, although this is expected to be lower than a pure equity portfolio. The model will sit within risk profile 5 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.

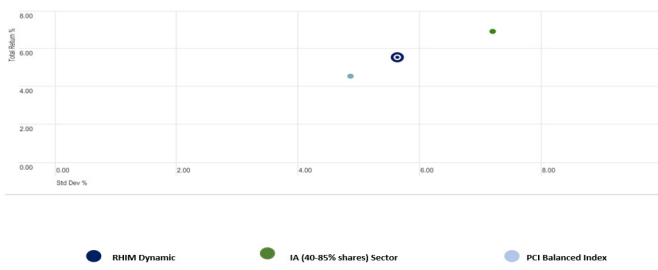


Commentary

December 2019 UPDATE

The Dynamic model was up 2.7% over the last three months as UK equities gained on the likelihood of a Conservative win in the election. Smaller companies with a focus on the UK were cheaper given the threat of Brexit and Corbyn's Labour party so they rallied the most. The Dynamic model was biased to these companies and two of the funds were up 10% in the quarter and two were up 15%. Overseas equities struggled to make money in sterling terms as the pound strengthened but the two emerging market funds were up 3-4% as beneficiaries of the sharp increase in liquidity now being provided by the U.S. central bank. This was also a helpful backdrop for the gold price and the fund's gold equity fund which was up 6% in the quarter. Gold is a useful hedge against a weaker dollar and geopolitical tension as was proved when the U.S.A. killed the second-most powerful man in Iran at the end of the year. Over the year, the Dynamic model was up 13.4% as equities and bonds have risen on the back of easier monetary conditions even though the global economy has slowed.

Risk Return (5 years) as at 31st December 2019

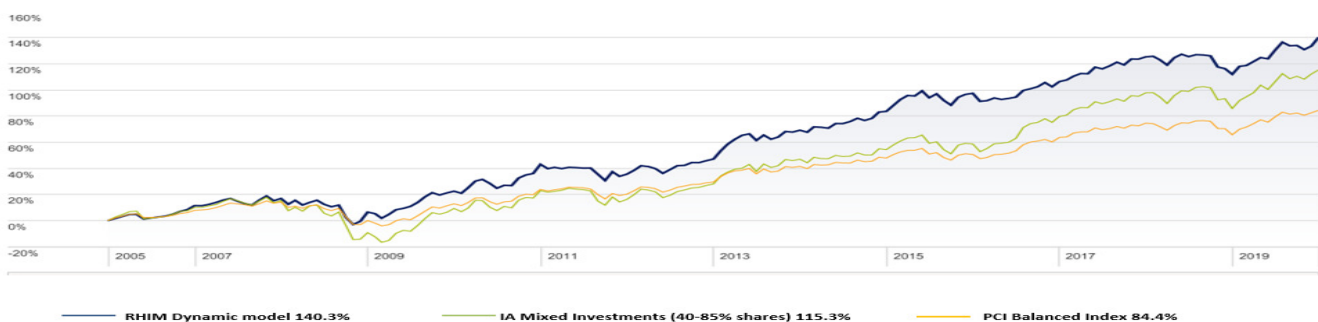

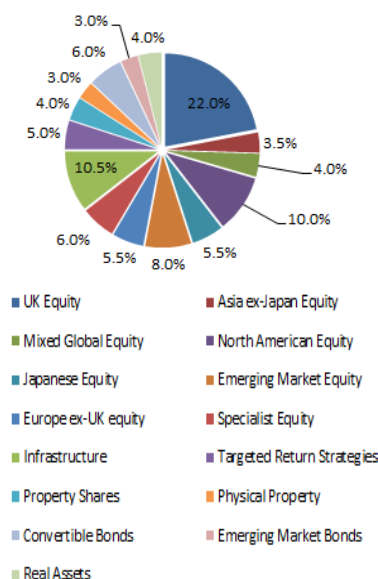
