

RHIM CAUTIOUS MODEL FACTSHEET

The RHIM Cautious model aims to deliver capital growth over the medium term, with lower volatility than the sector average using collective investment schemes (funds). Asset allocation will be actively managed whilst maintaining a cautious risk profile. This is a multi-asset portfolio which may invest between 25% and 45% in traditional equity funds which will include UK and overseas equities. The remainder will be invested in lower risk funds such as targeted absolute return funds and at least 35% across fixed income and property. The model is also permitted to hold up to 10% in cash when deemed appropriate. In order to deliver returns in excess of cash over the longer term investors must accept that the investment could fall in value, particularly in the short term. The model will sit within risk profile 4 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.




Commentary

January 2020 UPDATE

The Cautious model was up 2.0% over the last three months as UK equities rose in the run-up to the election and afterwards. They have subsequently given up some of these gains as the Brexit negotiations restarted and the FTSE 100 was up 1.1% over the period. Smaller UK companies that were most exposed to the election result did the best and the Franklin UK Managers' Focus fund was up 8%. All equities benefitted from the fresh liquidity the U.S. Federal Reserve pushed into the market and the model's global equity funds performed well with the M&G Global Listed Infrastructure fund up 8.4%. The additional liquidity was also good for gold. The gold equity fund was up 6% over the period after falling 5% in January even though the gold price was up 5% in the month. The model's bond holdings made a small positive return of 1-2% over the three months but the model's real assets did better with returns of 2-4%. The infrastructure assets performed well but renewables struggled when the oil price fell in January. Over the year, the Cautious model was up 5.9% as assets rose on the back of easing monetary conditions.


Risk Return (5 years) as at 31st December 2019
