RHIM DYNAMIC MODEL FACTSHEET

The RHIM Dynamic model aims to produce an attractive level of capital growth over the medium term with lower volatility than the IA sector, investing in collective investment schemes. This is a multi-asset global portfolio with an equity weight of between 50% and 75% which will involve investing in UK and overseas equities, including emerging markets. However, the model will typically also use targeted absolute return funds in order to reduce volatility associated with equity investing and at least 15% will be also invested in fixed interest and/or property as deemed appropriate. Asset allocation will be actively managed around the higher side of medium risk profile. This means investors should be comfortable with periods of volatility, although this is expected to be lower than a pure equity portfolio. The model will sit within risk profile 5 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.

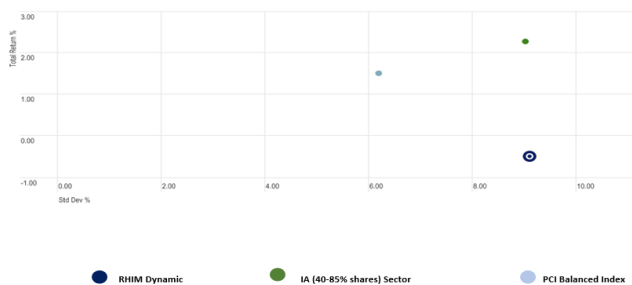


Commentary

May 2020 UPDATE

The Dynamic model was up 3.9% in May as markets continued to climb on the increasing monetary stimulus from central banks and the surge in money supply encouraged investors to take on more risk. Europe was the best-performing equity region as the continent emerged from lockdown, leading national companies were bailed out and central banks launched stimulus packages. Our two European equity funds were up 8.9% while the Japanese market was also up 8% on the back of a similar package in Japan. Improved investor sentiment caused a bit of a rotation at the end of the month into the more cyclical sectors and some weakness in the U.S. dollar. This was helpful for some of our emerging market funds. The Aubrey Global Emerging Markets fund was up 8.5% in May while our Latin America fund performed strongly at the end of the month. The increased money supply helped companies to refinance themselves in the convertible bond market and the Polar Capital Global Convertible bond fund was up 6.8% on the higher yields now available. The gold fund was up 11.5% as investors worried about weakening currencies.

Risk Return (5 years) as at 31st March 2020

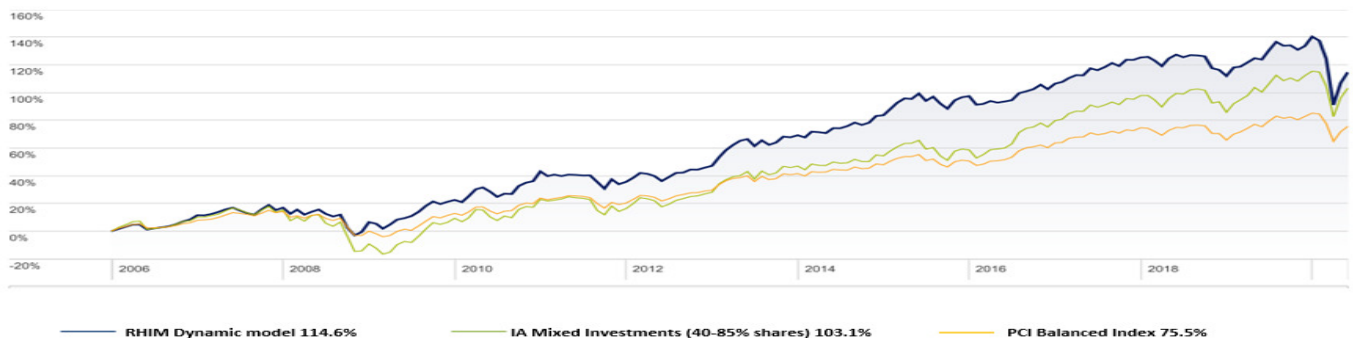

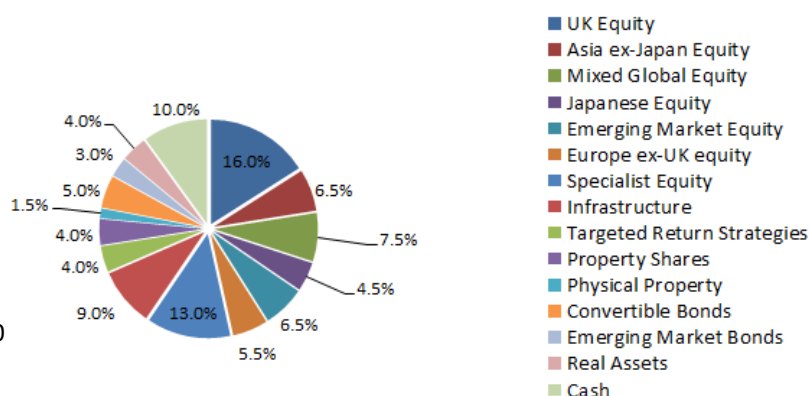
