

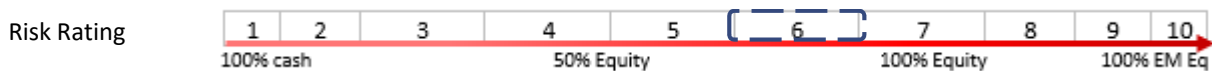

RHIM ENTERPRISE MODEL FACTSHEET

The RHIM Enterprise model aims to achieve long term capital growth by investing in collective investment schemes. This is a multi-asset portfolio with an equity weight of between 60% and 85% which will involve investing in UK and overseas equities, including emerging markets. In seeking higher returns, the model may also utilise specialist sectors which may experience periods of higher volatility. However, the model will also hold between 15%-40% in medium or lower risk investments such as targeted absolute return funds, fixed interest and/or property. The model will sit within risk profile 6 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Investors accept that this model has historically experienced volatility of around 10% per annum. Please see the reverse for historical volatility and peak to trough data.

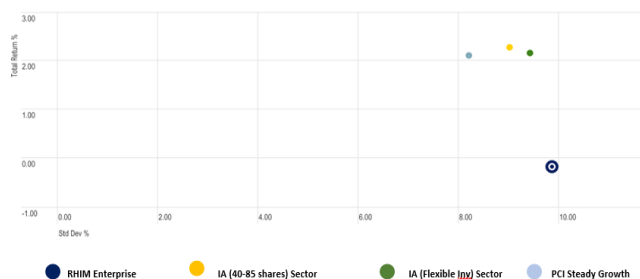


Commentary

May 2020 UPDATE

The Enterprise model rose 4.1% in May on the back of the much-increased money supply. The U.S. Federal Reserve started to buy corporate bonds as well as U.S. government debt while Europe and Japan also saw new stimulus packages. As a result, their stockmarkets were the best performing regions in May with both up over 8%. The Merian Gold & Silver fund was the best performing fund in the model, up 11.5% in May, as investors worried about weakening currencies given all the stimulus. The U.S. dollar declined slightly towards the end of the month and this was a fillip to some of our emerging market funds. The Aubrey Global Emerging Markets fund was up 8.5% in May while the Latin America fund performed strongly at the end of the month. The increase in money supply was also good for the M&G Emerging Markets Bond fund, which was up 7.7% in May, and the Polar Capital Global Convertible bond fund was up 6.8% as companies could refinance themselves (at higher rates) in the convertible bond market. The infrastructure and real asset funds were up 2-4% on the better investor sentiment.

Risk Return (5 years) as at 31st March 2020

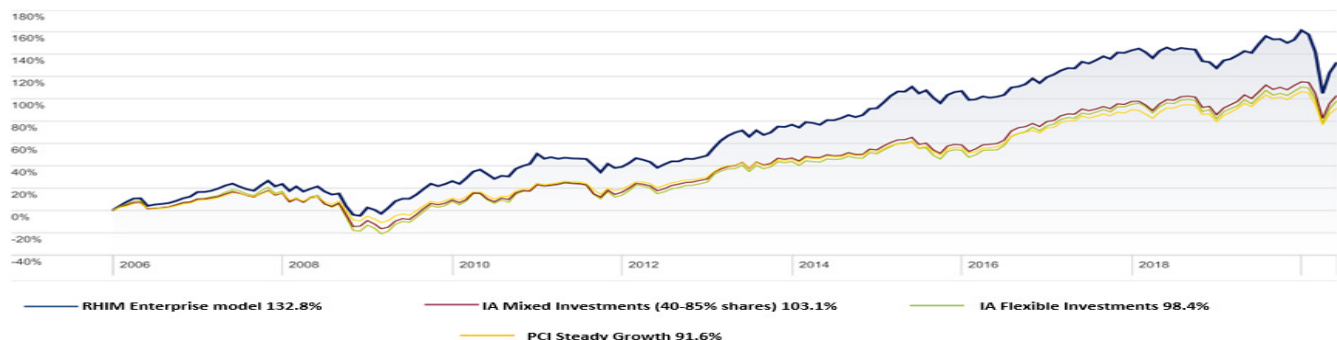

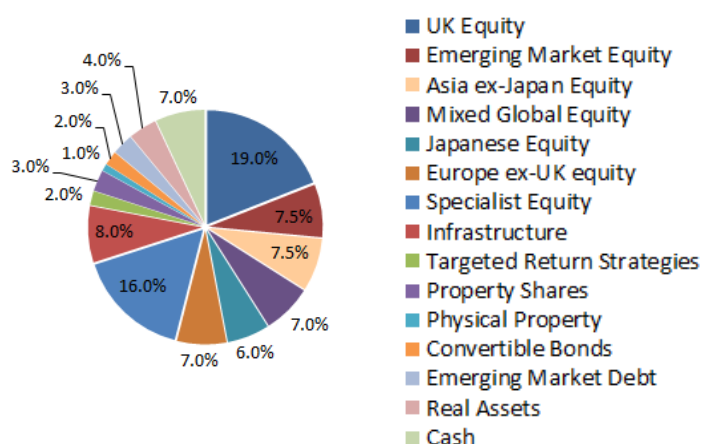
