


RHIM CAUTIOUS MODEL FACTSHEET

The RHIM Cautious model aims to deliver capital growth over the medium term, with lower volatility than the sector average using collective investment schemes (funds). Asset allocation will be actively managed whilst maintaining a cautious risk profile. This is a multi-asset portfolio which may invest between 25% and 45% in traditional equity funds which will include UK and overseas equities. The remainder will be invested in lower risk funds such as targeted absolute return funds and at least 35% across fixed income and property. The model is also permitted to hold up to 10% in cash when deemed appropriate. In order to deliver returns in excess of cash over the longer term investors must accept that the investment could fall in value, particularly in the short term. The model will sit within risk profile 4 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.




Commentary July 2020 UPDATE

The Cautious model continued its recent good performance by rising 1.9% in July. The US dollar weakened and this was beneficial in several ways. The model contains a position in the hedged share class of the Artemis US Select fund and this fund was up 7.6% in July while the unhedged share class was only up 0.7%. The weak dollar is also good for gold and emerging markets and the Merian Gold & Silver fund was up 18% in July. The Asian and emerging market equity funds were up 2% while the FTSE 100 was down 4%. We prefer smaller companies in the UK that have better growth potential and which are quicker to adapt to changing conditions and the Franklin UK Smaller Companies fund outperformed the FTSE 100 by 2%. The real asset funds and the fixed income funds were up 2-3% as bond yields tightened. The Cautious model is up 6.7% over the last three months, outperforming the Investment Association peer group by 2.5%. We think this should continue as the dollar weakens.




