

# RHIM CAUTIOUS MODEL FACTSHEET

The RHIM Cautious model aims to deliver capital growth over the medium term, with lower volatility than the sector average using collective investment schemes (funds). Asset allocation will be actively managed whilst maintaining a cautious risk profile. This is a multi-asset portfolio which may invest between 25% and 45% in traditional equity funds which will include UK and overseas equities. The remainder will be invested in lower risk funds such as targeted absolute return funds and at least 35% across fixed income and property. The model is also permitted to hold up to 10% in cash when deemed appropriate. In order to deliver returns in excess of cash over the longer term investors must accept that the investment could fall in value, particularly in the short term. The model will sit within risk profile 4 on a scale of 1-10, where 1 is cash and 10 is 100% high risk equity markets. Please see the reverse for historical volatility and peak to trough data.




Commentary

**August 2020 UPDATE** 

The Cautious model continued its recent run of good performance into August by rising 1.4% and outperforming its peer group by 0.6%. The US dollar continued to weaken and this was beneficial in several ways. The currency-hedged share class of the Artemis US Select fund, which is in the model, was up 5.0% in August while the unhedged share class was up 3.6%. The weaker dollar is also good for Asia and emerging markets and the JPM Asia Growth fund was up 6.2% in August and the RWC Global Emerging Markets fund was up 4.1%. The UK's FTSE 100 was one of the weaker markets, up 1.8% in the month, but we prefer smaller companies for their higher growth and adaptability and the Franklin UK Smaller Companies fund was up 4.2%. The strategic bond funds were down slightly as comments from the U.S. Federal Reserve caused bond yields to rise. The real asset and infrastructure funds that we prefer instead were up nearly 2%. While we expect a short-term correction before the U.S. authorities launch more stimulus packages, we believe the Cautious model should continue to do well as the dollar weakens.


# Risk Return (5 years) as at 30th June 2020


